

## PBEC CALLS ON APEC FOR LEADERSHIP, SEEKS REDUCED BARRIERS TO MOVEMENT OF WORKERS

SHANGHAI (October 18, 2001) - The Pacific Basin Economic Council today endorsed policy recommendations urging decisive leadership from APEC in the wake of the Sept. 11 terrorist attacks on the United States, and calling for aggressive liberalization of GATS commitments affecting the temporary entry of natural persons.

In its statement on APEC leadership, PBEC noted that the threat of a global recession is greater now than perhaps any time in APEC's history, and called on APEC to act decisively on three fronts: trade and investment liberalization, economic stimulus, and appropriate anti-terrorism measures. In its statement on temporary entry, PBEC asserted that short-term personnel transfers - specifically in areas of knowledge-based service industries like insurance and information technology and professional services like consulting, accountancy and law are a trade issue, not an immigration issue. The Board noted that reduced trade barriers achieved through the WTO will be mooted if businesses are not able to move people in a timely and efficient manner.

During the meeting, PBEC members - joined by a number of special quests – were also priviledged to hear special remarks by several business and government leaders, including: Minister Shi Guansheng of the Ministry of Foreign Trade and Economic

of the city of Shanghai, China; Ambassador John Huntsman, Deputy U.S. Trade Representative; and James C. Morgan, Chairman and CEO of Applied Materials.

PBEC's Mid-term Meeting brings together the organization's inner circle, to discuss and issue policy recommendations, to participate in working committee meetings on areas ranging from electronic commerce to transparency, and to chart the future direction of PBEC.
